Please refer to the ACES Web site for the latest details. The principal matter, worthy of repetition here, is the requirement that the name of <u>any visitor</u> to the NPS facility must be submitted for screening and approval at least 24 hours in advance. Hence, advance registration for this year's conference is very important. Dick Adler will submit the list of advance registrations to NPS security for clearance, so the clearance procedure will be taken care of automatically if you register in advance. Walkup registrations at conference time will have a delay, if not a major problem. For emergency reference, Dick's NPS office telephone is 831-656-2352. The conference registration area will also have a telephone, but that number is unknown at the time of this writing. We will try to get approval to post that phone number at the NPS facility gates, but there is no guarantee that we will be allowed to do that, so be prepared. Again, an advance registration is the only safe and sure way to go!

We have lost many papers for this year's conference because they had military or national laboratory sponsorship that has become sensitive, so numerous papers could not get clearance for presentation. As DoD, DOE, and other government agencies get new review procedures and standards into practice, it is reasonable to expect that the situation will be significantly improved by the time 2003 rolls around. The present alignment of the planets and stars hints that the conference will be smaller than usual this year, despite the exceptional efforts of Ross Speciale as ACES 2002 Chair. That is simultaneously good news and bad news. The attendance and support of those who will travel to Monterey and join us in March is appreciated, and you should expect to enjoy an especially collegial and unfettered conference environment this year. With a somewhat more relaxed conference schedule, akin to earlier years fondly remembered by many ACES old-timers, I hope you will benefit from more time spent in private conversations and networking with your CEM colleagues from near and far.

The conference is the centerpiece of ACES activity. I encourage you to rally around and promote the conference as we begin to look ahead to 2003, a new year which will hopefully bring happier times, more optimistic spirits, and cheer to both our country and other nations around the world.
